It focuses on reading comprehension, writing clarity, and understanding standard written English. Additionally, basic test-taking computer skills for HSE exams are integrated. Completion of the program equips students to enter the workforce, pursue CTE programs, or continue their education. g. The new High School Equivalency (HSE) program was developed in response to Assembly Bill 86, which tasked the California Department of Education and the California Community College Chancellor's Office with addressing adult education needs. In 2015, the South Orange County Regional Consortium's Final Plan highlighted the significant number of adults in the region lacking a high school diploma or basic literacy skills. This program aims to provide a pathway for adults to earn a High School Equivalency Certificate, preparing them for the workforce, career and technical education programs, or academic post-secondary education.
